### **Other Relevant Dates for the 2024 State Primary Election:**

**Friday, July 19, 2024** (The last day of the 30-day reporting period)

The last day a candidate may give or loan their campaign more than \$5,000.

**Friday, October 4, 2024** (45 days after the date of the Primary Election)

The last day a candidate not in the General Election may accept contributions.

**Saturday, February 1, 2025** (90 days after the date of the Primary Election)\*\*

The date by which candidates not in the General Election must distribute the amount held in their campaign account.

<b>Final Report</b>	October 27– February 1, 2025	<b>Tuesday, February 18, 2025</b>

### **Other Relevant Dates for the 2024 State General Election:**

**Friday, October 4, 2024** (The last day of the 30-day reporting period)

The last day a candidate may give or loan their campaign more than \$5,000.

**Friday, December 20, 2024** (45 days after the date of the General Election)

The last day a candidate may accept contributions.

**Saturday, February 1, 2025** (90 days after the date of the General Election)\*\*

The date by which candidates must distribute the amount held in their campaign account.

\*During the 9 days before either election, contributions in excess of \$250 from a single source must be reported by date, amount, and contributor within 24 hours of receipt. This includes all monetary, non-monetary, and candidate contributions, as well as contributions of more than \$250, in the aggregate, from a single contributor during the 9-day period. You may need to report each day during that period, or not at all.

\*\*Deadline is on a weekend – will be considered timely if completed the next business day.
