### **Tuesday, October 2, 2012 Statewide Municipal Elections**

<b>24 Hour Reports**</b>	September 23 – October 1	<b>Daily As Needed**</b>
<b>105 Day Report</b>	September 23 – December 31, 2012	<b>Tuesday, January 15, 2013</b>

\* Due date falls on a state holiday. Reports will be considered timely, if filed the day immediately following the holiday.

\*\*During the 9 days before an election, you must report the contributor name and amount of all monetary and non-monetary contributions over \$250 to the APOC within 24 hours of the time you receive each contribution. You may need to report each day during that period, or not at all. You must fax, phone-in, or hand-carry the report. **Do not mail 24 Hour Reports.**

### **Other Relevant Dates for the 2012 Statewide Municipal Elections:**

**Friday, August 31, 2012.** (Last day of 30 day reporting period for the October 2, 2011 Municipal Election)

The last day that a candidate may give or loan their campaign more than \$5000

**Friday, November 16, 2012.** (45 days after the date of the October 2, 2012 Municipal Election)

The last day a candidate may accept contributions

**Monday, December 31, 2013** (90 days after the date of the October 2, 2012 Municipal Election)

The date by which candidates must disburse the amount held in their campaign account
