LATE REPORT: 30 Day Report

MAXIMUM CIVIL PENALTY: \$220. Filed 22 days late at \$10/day STAFF RECOMMENDATION: Reduce penalty by 50% to \$110

The group was confused by the required use of Excel instead of the ELFS system. They made a good faith effort to file the report by seeking assistance from staff when they discovered they were late.

Commissioner Ballenger moved to accept the staff recommendation to reduce the civil penalty by 50%.

### **Investigation Report: Starr v Brand, 08-03-POFD/CD [9]**

The commission held a hearing on the above matter. The commission found that Ms. Brand violated AS 39.50 by failing to file a complete public official financial disclosure statement. For this omission the commission assessed a civil penalty of \$25, which was mitigated because Ms. Brand immediately provided the missing information.
