NOTICE OF HEARING AND PROCEDURAL ORDER

A hearing in this case will take place before the Alaska Public Offices Commission at approximately 2:30 p.m. on Wednesday September 10, 2025.

The Commissioners will be present in person, by telephone, or via Microsoft Teams and will receive evidence regarding this matter. You may be present at the hearing either by telephone (1-907-202-7104, Access Code: 218 853 540#), in-person (2221 E. Northern Lights Blvd, Ste 128, Anchorage, Alaska), or via Microsoft Teams Meeting. You may be, but are not required to be, represented by an attorney or agent.

If you wish to participate by telephone and are an individual who requires a special accommodation to participate, you must advise the Commission office on or before September 3, 2025, so that a special accommodation can be made.

PREHEARING AND HEARING PROCEDURES

- 1) Parties. The parties in this case are Commission Staff and Respondents.
- 2) Issues. At the hearing, the Commission will consider whether Respondents failed to include complete details of true sources, failed to file complete expenditure reports, and failed to include a supported candidate's name in its group name and paid-for-identifiers in the 2024 State General Election.
- 3) Procedural history. Complainant David Long filed a complaint against Respondents Joel Borgquist and Keep It Alaska IE group on January 10, 2025. Respondents did not file a response. Staff's investigation report was issued August 13, 2025.

- **4) Hearing procedures.** The hearing will be conducted as provided in AS 15.13.380, 2 AAC 50.891, and the Alaska Administrative Procedure Act, AS 44.62.330 44.62.630. All testimony must be presented or submitted under oath. A party may call witnesses, cross-examine witnesses, present and rebut evidence. If the respondent does not testify, the respondent may be called and examined as if under cross-examination.
- 5) Evidence and exhibits. All relevant evidence may be admissible at the hearing. In passing upon the admissibility of evidence, the Commission may consider, but is not bound to follow, the rules of evidence governing general civil proceedings in the courts of the State of Alaska. The Commission may exclude inadmissible evidence and order repetitive evidence discontinued.
- 6) Prehearing filings. No later than September 2, 2025, a party:
 - a) may file a list of witnesses expected to testify at the hearing;
 - b) may file copies of exhibits to be presented at the hearing that are marked and identified (for example, Resp.'s Ex. A);
 - c) may file a prehearing memorandum;
 - d) may file prehearing motions, including motions to dismiss, for summary judgment, or to exclude evidence, and
 - e) shall serve all parties and the Complainant with filings submitted.
- 7) Response to motions and requests for subpoenas. No later than September 9, 2025, a party
 - a) may respond to a motion; and
 - b) may request the Commission to issue subpoenas to compel the attendance of witnesses, the production of documents, or other things related to the subject of the hearing, and is responsible for serving the subpoena and paying the appropriate witness fee.
- **8)** Extensions of time. Requests to extend the deadlines in this order must be in writing, filed with the Commission, served on all parties and the Complainant, and supported by good cause.
- **9) Burden of proof.** The Commission staff has the burden to prove any charges by a preponderance of the evidence.

- **10) Order of proceedings.** Matters considered at a hearing will ordinarily be disposed of in substantially the following order:
 - a) pending motions, if any;
 - b) complainant may present argument under 2 AAC 50.891(d)
 - c) presentation of cases as follows, unless otherwise ordered by the Commission:
 - The Commission Staff's direct case, including the investigative report, evidence, and testimony of witnesses;
 - ii) Respondent's direct case;
 - iii) Rebuttal by the Commission Staff; and
 - iv) Closing statements, if any, by Respondent and Commission Staff.
- **10) Decision and Order.** The Commission will issue an order no later than 10 days after the close of the record.

SUMMARY OF COMPLAINT AND RESPONSE

Complainant David Long alleges Respondent Joel Borgquist and Keep It Alaska independent expenditure (IE) group violated Alaska campaign disclosure law by failing to properly identify true source contributors, making prohibited contributions, accepting prohibited contributions, not disclosing expenditures, and "planning and coordinating" between groups and individuals. Respondents Joel Borgquist and Keep It Alaska IE group did not file a response.

SUMMARY OF APOC FINDINGS

Complainant asserts several allegations against Respondents. As described in further detail in the Law and Analysis section, this staff report addresses only those allegations against persons named as parties to the complaint and that constitute violations of Alaska campaign disclosure law. They include failing to include required details concerning true sources and failing to file independent expenditure reports due within ten days of the expenditure. During staff's investigation of the group's financial activities, it was also determined that Keep It Alaska failed to include a supported candidate's name in its group name and paid-for-by identifiers.

BACKGROUND FACTS

On April 1, 2024, Joel Borgquist registered Keep It Alaska (KIA) as an IE group, identifying its purpose as "supporting/opposing state and local candidates, causes, and

ballot measures" and its campaign plans as the Anchorage Municipal, State General, and State Primary. Borgquist named himself as chair.

Borgquist is also the manager and registered agent of Red Dirt Campaigns LLC.² According to its website, Red Dirt Campaigns "run(s) campaigns for candidates" and provides campaign planning and management, messaging, and digital ads among its services.³ Borgquist initially listed "joel@reddirtcampaigns.com" as an additional email for KIA group email but later replaced it with chair@keepitalaska.org.

KIA's treasurer is Tom Datwyler of Dublin, Ohio and KIA's group address originally was Datwyler's Ohio address. Datwyler appears to be the same individual as Thomas Datwyler of Hudson, Wisconsin, treasurer and custodian of records for Keep It Alaska Federal PAC (KIA Fed), formed on February 29, 2024.⁴

a. 2024 Anchorage Municipal Runoff Election

On April 11, Borgquist identified KIA's intention to expend 33 1/3 or more of its funds in support of Dave Bronson, one of two candidates in the Anchorage Mayoral (Runoff) Election held May 14, 2024:⁵

INDEPENDENT EXPENDITURE GROUP

More than 1/3 of total spending going to the following candidate(s).

Dave Bronson

As he completed KIA's registration forms, Borgquist requested and received APOC staff assistance, by phone and email. Borgquist first called APOC and explained that the group planned to have a fundraiser to support Bronson's race and asked whether Bronson

could attend and speak at the fundraising event. On April 11, APOC staff responded to Borgquist via email and advised that under Alaska campaign disclosure law, an "independent expenditure" group supporting a candidate could not coordinate activities with that candidate, including fundraisers. In this same email, APOC staff informed Borgquist that under AS 15.13.050(b), KIA must include Bronson's name in KIA's group name because KIA – per its registration – intended to spend more than one-third of its spending in support of the candidate. Borgquist replied to the APOC staff email asking for "clarity" about the timeframe of the "1/3 statute," noting KIA had "no way of guaranteeing future donations" and asking how the "1/3 statute" could be met. Borgquist also asserted that the statute violated the group's First Amendment right to freedom of association. The following day, April 12, 2024, Borgquist deleted the group's stated intention to spend one-third of its spending on Dave Bronson:

On April 16, 2024, Borgquist sent APOC staff a "tester" flyer supporting Bronson,⁹ asking for input on the communication disclaimer.¹⁰

On April 17, 2024, APOC staff again communicated with Borgquist regarding group name requirements, noting that "if you are able to provide more specific information about the group's planned activities, staff may be able to provide further guidance." Borgquist asked no further questions concerning the group name requirement.

On April 27, 2024, Borgquist filed KIA's first independent expenditure report, reflecting \$3,750 of debt to support "2024 – Dave Bronson Election" in the Anchorage Municipal Runoff election, including \$1,500 to Red Dirt Campaigns. 12

On April 30, 2024, KIA's treasurer Thomas C. Datwyler filed a 24-hour true source report, disclosing \$9,925.48 in contributions transferred from KIA Fed PAC to KIA (IE group) from April 4 through April 24. The report disclosed the funds were from 46 individual contributors, all channeled through an intermediary identified as "Keep It Alaska 'Federal." KIA Fed PAC, as the contributor, did not file a statement of contribution itself.

On May 3, 2024, Datwyler as KIA's treasurer filed a 24-hour true source report, disclosing an additional \$1,800 in contributions from KIA Fed PAC from April 25 through April 26. The report discloses four individuals as true sources, again all channeled through Datwyler's "Keep It Alaska (Federal)" as an intermediary, on May 2.¹⁴ KIA Fed as the contributor did not file a statement of contribution.

Also on May 3, 2024, Datwyler filed an independent expenditure report for KIA disclosing \$11,147.11 in paid expenditures and a \$1,500 debt (to Red Dirt Campaigns) from April 24 through May 1. The reported expenditures and debt all indicated they were to support "2024 – Dave Bronson Election." ¹⁵

On May 7, 2024, Datwyler filed KIA's 7-day report for the Anchorage Municipal Runoff Election, disclosing \$17,263.48 in total contributions and \$16,097.11 in expenditures.¹⁶

On May 8, 2024, in a 24-hour true source report, KIA reported \$1,040.48 in contributions from "Keep It Alaska Federal PAC" on May 8, from three true sources s from May 1 through May 2, but did not disclose how much came from each true source.¹⁷

Also on May 8, 2024, Datwyler filed an independent expenditure report showing \$1,631.32 in expenses in support of "2024 – Dave Bronson Election" and showing KIA with \$0.00 funds remaining but disclosed no contributions. 18

The Anchorage Municipal Runoff Election occurred May 14, 2024.

Datwyler filed KIA's "No Activity" 105-day report to close out the Anchorage Municipal Runoff Election cycle on August 13, 2024, and August 15, 2024. The report disclosed \$0.00 for cash on hand, income, expenditures, and debts. Year-to-date totals were only disclosed on October 7, 2024, when KIA amended its next report, the 30-day primary report.

b. The August 20, 2024 State Primary Election

On July 15, 2024, Datwyler filed KIA's 30-day report for the State Primary – KIA's first report for an election other than the Anchorage Municipal Runoff Election. ²⁰ Datwyler amended the report October 7, 2024 to "correct cash on hand" to \$1,476.95 and to include year-to-date income of \$18,303.96 and year-to-date expenses as \$16,827.01. ²¹ This report disclosed a June 10, 2024 expenditure of \$729 for "voter data" but disclosed no contributions and no other expenditures for the State Primary Election. KIA filed no independent expenditure report for the voter data expenditure.

c. The November 6, 2024 State General Election

Datwyler filed "No Activity" 30-day²² and 7-day²³ reports for the State General Election reflecting no change in its finances from the State Primary. KIA reported no contributions and no expenditures during the State General Election cycle.

d. Post-election contribution and expenditure on December 13, 2024

On December 13, 2024 Datwyler filed a 24-hour true source report to disclose KIA's receipt of a \$3,000 contribution from KIA Fed PAC made on December 12, 2024.²⁴ On this same day, KIA made a \$3,000 contribution to the Alaska Voter Coalition²⁵ that was then used to make that group's only expenditure – a payment to satisfy a debt incurred two months prior for \$3,000 of work by Borgquist's company Red Dirt Campaigns.²⁶

KIA did not file an independent expenditure report for the \$3,000 contribution made to Alaska Voter Coalition. True sources Trenitie Yundt, Anthony Pitcher,²⁷ and Robert Hall contributed the funds to Datwyler's KIA Fed PAC prior to the State General Election – Yundt and Pitcher on October 21 and Hall on October 28.

LAW AND ANALYSIS

Complainant Long asserts a number of allegations against respondents Joel Borgquist and KIA. Some of the facts Long points to are true but do not, by themselves, violate APOC laws and regulations; for example, that KIA (IE group) and KIA Fed PAC share the same banks, or that KIA received contributions through an intermediary, or that there is planning and coordinating of various campaign activities.²⁸ Long also makes

allegations concerning John Carr and Alaska Voter Coalition IE group, but Long did not name them as parties to this complaint; additionally, these same allegations are addressed in a separate complaint brought by Long, 25-02-CD, *Long v. Carr, Alaska Voter Coalition*.

In this staff report, APOC staff addresses only those facts in the complaint that constitute violations of Alaska campaign disclosure law against those named as parties to the complaint, Joel Borgquist and KIA. The violations found by staff include failing to include a supported candidate's name in KIA's group name and paid-for-by identifiers, failing to include required details concerning true sources, and failing to file independent expenditure reports due within ten days of the expenditure, as follows:

a. <u>KIA failed to identify and include candidate Dave Bronson in its group</u> name and failed to identify Bronson in its paid-for-by identifiers.

Alaska campaign disclosure law requires a group intending to contribute or expend "33 1/3 percent or more of its funds" on behalf of one candidate to include the name of that candidate in its group name.²⁹ If a group's name does not initially include the supported candidate's name, the group must change its name to make it "readily apparent to the general public" that the group supports that candidate.³⁰ Alaska campaign disclosure law also requires a group to use the full group name identifying the supported candidate in its paid-for-by identifiers required by AS 15.13.090.³¹

Alaska Statute 15.13.050(b)'s mandate that a group identify a supported candidate is one of "intent": "If a group *intends* . . . to contribute to or expend on behalf of one candidate 33 1/3 percent or more of its funds, the name of the candidate shall be a part of the name of the group." (Emphasis added.) Assessment of a person's subjective intent can be difficult, and .050 does not list specific indicia of intent upon which to evaluate it. Still,

intent may be inferred from actions.³² In this matter, Borgquist and KIA's actions provide a preponderance of evidence indicating an intent to spend one-third or more of its funds to support Bronson:

- 1. KIA stated that it planned to utilize more than one-third of its total spending to support Bronson on its group registration April 11, 2024.
- 2. On April 12, 2024, after the group learned campaign disclosure law required Bronson's name to be included in KIA's group name, it deleted its statement of intent to support Bronson.
- 3. In the following six weeks, until the May 14, 2024, Anchorage Municipal Runoff Election, 100% of KIA's total spending supported Bronson.
- 4. During the year 2024, KIA made only two expenditures to support any candidate other than Bronson in any election for which it registered (the 2024 Anchorage Municipal Runoff, State Primary, and State General Elections), with two exceptions: a \$729.90 expenditure for "voter data" during the State Primary, and a post-State Election contribution on December 12, 2024 of \$3,000 made to Alaska Voter Coalition IE group.³³
- 5. KIA spent more than \$16,000 of its \$21,000 in contributions to support Bronson.³⁴
- 6. Only after all elections finished did KIA make a post-election contribution of \$3,000 to another IE group for the State General Election.

In objecting to the "33 1/3" naming requirement of AS 15.13.050(b), Borgquist asserted KIA's difficulty in identifying supported candidates and races when it had "no way of guaranteeing future donations." While it's the rare entity that will know exactly what its future donations will be, this uncertainty does not render it impossible to identify

which candidate or races the group *intends* to support – particularly so where a race, like the Anchorage Municipal Runoff Election – features only two candidates. And any uncertainty does not absolve persons from complying with the statute. A group can always amend its registration if circumstances change, with a few simple keystrokes. Amending "paid-for-by" identifiers similarly would have taken little effort; KIA effected its support for candidate Bronson primarily through digital communications, so it could have quickly and at little cost edited its campaign communications to reflect its intent to support the candidate.

Finally, it must be noted that KIA was far better equipped than most groups to understand what its future donations would be, because virtually all of them came from KIA Fed PAC, controlled by KIA's own treasurer, Datwyler. Under these circumstances, KIA's protest that it could not comply with AS 15.13.050(b) – because it had no way of guaranteeing future donations – is disingenuous, at best.

A preponderance of the evidence supports that KIA violated AS 15.13.050(b) by failing to include Bronson's name in its group name and violated AS 15.13.090 by failing to include Bronson's name in its paid-for-identifiers.

b. KIA failed to provide complete true source information on 24-hour true sources reports filed May 8, 2024 and December 13, 2024.

Once an entity making independent expenditures in a candidate election receives contributions exceeding \$2,000 "from an individual, person, nongroup entity, or group" in a single year, AS 15.13.110(k) requires that entity to report the contribution within 24 hours.³⁶ The 24-hour report must identify "the true source, and all intermediaries" of the contribution.³⁷

When KIA filed its 24-hour report disclosing the contribution from KIA Fed PAC on May 8, 2024, it provided the names of true sources Ralph Samuels, Susan Edwards, and John White Jr. behind the collective \$1,040.48 contribution but did not identify amounts

attributable to the true sources. Similarly, when KIA filed its 24-hour report for another KIA Fed PAC contribution on December 13, 2024, it again provided no details beyond names of true sources Trenitie Yundt, Anthony Pitcher, and Robert Hall.

Where a person discloses 24-hour contributions under AS 15.13.110(k), the report "must include . . . the following information":

- (1) the date of each contribution;
- (2) the amount of each contribution;
- (3) the full name of the contributor;
- (4) a description of item or services contributed, if necessary; and
- (5) the full name of all intermediaries, if any, within the meaning of "true sources" under AS 15.13.400.³⁸

In failing to provide complete true source information in its May 8 and December 13 24-hour true sources reports, KIA violated AS 15.13.110(k) and 2 AAC 50.270(d).

c. <u>KIA failed to file independent expenditure reports, filed incomplete independent expenditure reports, and failed to file a statement of contribution within 24 hours of making a contribution in excess of \$2,000.</u>

Under Alaska campaign disclosure law, each group must fully report all expenditures made, incurred, or authorized by it, including their dates and amounts, and separately file an independent expenditure report.³⁹ In its independent expenditure report, the group must identify the candidate supported or opposed by each expenditure, disclose each contribution to include the name, date, and amount, and file it not later than 10 days after making the expenditure.⁴⁰ Additionally, a group that contributes more than \$2,000 to an entity that makes independent expenditures in candidate elections must disclose the contribution and identify its true sources within 24 hours.⁴¹

On June 10, 2024, KIA made a \$729.90 expenditure to i360 through an electronic funds transfer. While the expenditure was reported on KIA's 30-day primary report, it

failed to file an independent expenditure within 10 days as required by AS 15.13.040(d)-(e) and AS 15.13.110(h). On December 12, 2024, KIA contributed \$3,000 to Alaska Voter Coalition through an electronic funds transfer.⁴² While KIA reported this as an expenditure on its year-end report, it failed to file the required independent expenditure report within 10 days pursuant to AS 15.13.040(d) and (e) and AS 15.13.110(h). KIA also failed to file a statement of contribution within 24 hours of its contribution to the Alaska Voter Coalition as required by AS 15.13.040(r).

Additionally, based on KIA's 7-day report for the Anchorage Runoff election, it appears that its April 27, 2024 independent expenditure report failed to disclose \$5,038 in contributions and its May 3, 2024 independent expenditure report failed to disclose an additional \$500 contribution as required by AS 15.13.040(e)(5).

CONCLUSION

APOC staff finds by a preponderance of the evidence Borgquist and KIA violated Alaska campaign disclosure law by failing to identify supported candidates in its group name and paid-for-by disclaimers, failing to file independent expenditure reports, and failing to include full true source information in its 24-hour independent expenditure reports.

MAXIMUM CIVIL PENALTIES

The maximum civil penalty for reporting violations, other than a 7-day report or report under AS 15.13.110(b), is \$50 per day for each day the violation continues.⁴³ The maximum penalty for failing to file a statement of contribution under AS 15.13.040(r) is \$1,000 per day for each day the violation continues.⁴⁴

For purposes of calculating the penalty for failing to identify a candidate (Bronson) in a group name where the group states an intent to expend at least one-third of its funds on those candidates, the penalty runs from the time of registration through the day of the election. For purposes of calculating the penalty for inaccurate paid-for-by identifiers in its

communications, the penalty runs from the time of the communication through the day of the election.⁴⁵

For KIA's incomplete IE reports, the penalties run from the date they were filed until the contributions were first disclosed on the 7-day runoff report. For KIA's missing IE reports, the penalties accrue from 10 days after the date of expenditure (when the reports were due) until the expenditures were first disclosed on the 30-day primary report or the date the complaint was filed. For KIA's incomplete 24-hour true sources reports, the penalties accrue from the time of filing; for KIA's unfiled statement of contribution report, the penalty accrues from the day after the date of the contribution. For these reporting violations, the accrual of penalties are tolled on January 10, 2025, the day the complaint was filed.

MITIGATION AND RECOMMENDATION

When staff assesses penalties, the starting points for calculating those penalties are found in AS 15.13.390, which outlines applicable penalties for violations of Alaska's campaign disclosure laws, and 2 AAC 50.855, which outlines the penalty assessment procedure and available reductions. KIA was a first-time filer during the 2024 Anchorage Runoff Election; it had not filed any prior registrations or reports and had not participated in any prior elections in Alaska. As such, for KIA's violations related to their incomplete IE reports, regulation allow staff to simply document the violation and forego a penalty. The rest of the reporting violations may be assessed at 50% of the maximum under 2 AAC 50.855(b)(2)(C)(i) considering this was KIA's first election cycle. However, as discussed further below, staff does not recommend any reductions to the penalties associated with the group's registered name and inaccurate paid-for-by identifiers. Instead, staff recommends those penalties be assessed at the maximum under 2 AAC 50.865(d).

After the reduced assessment, staff looks to 2 AAC 50.865 for mitigation criteria that may apply for further reductions of the assessed penalty.

A civil penalty may be reduced by up to 50% if the person is an inexperienced filer who has been subject to reporting for less than one year. 46 2024 was KIA's first time participating in Alaska elections and at that time the group had been subject to reporting requirements for less than one year. Accordingly, the penalties for KIA's **reporting violations** can all be reduced by 50%.

A penalty may be further reduced, by a percentage greater than 50% or waived entirely, where it is "significantly out of proportion to the degree of harm to the public for not having the information," defined as exceeding the value of the transactions that were reported late, or for 24-hour reports, as exceeding twice the value of the transactions that were reported late.⁴⁷ staff takes into consideration that the information KIA's incomplete May 8, 2024 true sources report failed to disclose – individual amounts for a contribution

totaling \$1,040.48 – was only a portion of the required information, and KIA did provide the full information in its 105-day and year-end reports. APOC therefore recommends a further reduction by 90% to \$170 for KIA's penalty associated with the May 8 true sources report. For KIA's penalty for the December 13 true sources report (for the \$3,000 contribution), APOC applies the mitigator of 2 AAC 50.865(b)(6), where unique circumstances justify reducing the penalty, to reduce the penalty by 80%, to \$140, making the penalties commensurate for what is essentially the same violation. For the missing statement of contributions report, staff recommends a 95% reduction to \$700 based on the group's inexperience and because the contribution was made after the date of the election. 48

For failing to name its supported candidate in its group name and failing to name Bronson in its paid-for-by identifiers in election communications, 2 AAC 50.865(d) applies: A civil penalty may be imposed in the maximum amount where a person has a poor reporting history, as indicated by evidence suggesting deliberate non-reporting.⁴⁹ Here, evidence reflects APOC staff specifically informed KIA that Alaska campaign disclosure law required it to include Bronson in its group name as a candidate for whom one-third or more of their contributions or expenditures would support. KIA understood the requirement and thereafter took deliberate action to evade it by removing the 33.3% intention from its group registration. The group then immediately committed 100% of its contributions and expenditures to support Bronson. At no point did KIA amend its registration or take any action to inform voters through its paid-for-by identifiers of the group's intent. In failing to do so, KIA effectively circumvented a primary tenet of campaign disclosure laws, which is to provide information to the public for an informed electorate and to make voters aware of the financing behind election communications.

In all, staff recommends a civil penalty in the amount of \$4,535 as demonstrated below.



Introduction

This complaint addresses egregious violations of Alaska campaign finance law by the *Keep It Alaska Independent Expenditure Group* during the 2024 election cycle. The organization funded a coordinated disinformation campaign that broadcasted demonstrably false and defamatory attacks against multiple candidates, most notably Representative David Eastman in House District 27. Investigation reveals these malicious activities were financed through an elaborate dark money network centered around the Yundt family—specifically Trenitie Yundt, wife of Senator Rob Yundt—and the *Keep It Alaska* entities.

Of particular concern is the organization's intricate web of relationships with the Alaska Voter Coalition, Red Dirt Campaigns and <u>Keep It Alaska Federal Super PAC</u>—connections that suggest a calculated effort to conceal funding origins through a labyrinth of affiliated entities.

The impact of *Keep It Alaska's* deceptive practices extends beyond mere regulatory violations. Their carefully orchestrated campaign of misrepresentation and distortion materially influenced multiple election outcomes, undermining the integrity of Alaska's democratic process. These actions demand thorough investigation and appropriate enforcement measures to preserve the transparency mandated by state campaign finance laws.

Left unchecked, the tactics employed by *Keep It Alaska* and its network of affiliated organizations pose a serious threat to Alaska's democratic institutions.

When dark money groups can operate with impunity—concealing their true donors while launching coordinated attacks based on deliberate distortions—they rob Alaskans of their fundamental right to make informed decisions about their representation.

Such manipulation of the electoral process erodes public trust, discourages qualified candidates from seeking office, and ultimately threatens the very foundation of representative government in Alaska.

The Commission's decisive action on this complaint is essential not only to address these specific violations but to protect the integrity of Alaska's electoral system for future generations.

Dark Money Networks and Coordinated Electoral Deception in the 2024 Elections

Allegation Overview

This complaint alleges that *Keep It Alaska Independent Expenditure Group* violated Alaska campaign finance statutes and administrative codes by misreporting the true source of a \$3,000 contribution received on December 12, 2024, and by failing to ensure transparency and accuracy in the disclosure of campaign contributions. These violations pertain to AS 15.13.040(b), AS 15.13.400(19), AS 15.13.400(5), 2 AAC 50.258, and AS 15.13.070(c)(2).

The facts of the case indicate that *Keep It Alaska Independent Expenditure Group* accepted and transferred to another group \$3,000 in "dark money (as defined in AS 15.13.400(5)) from a source that clearly does not exist.

 - a. Indicates a \$3,000 contribution was received from Keep It Alaska Federal SuperPAC, listing the True Sources of income as:

 - 3. No occupation provided
 - 4. No employer provided
 - ii. Anthony Pitvher on 10/21/2024
 - 1. No individual amount disclosed
 - 2. No address provided
 - 3. No occupation provided
 - 4. No employer provided
 - iii. Robert Hall on 10/28/2024
 - 1. No individual amount disclosed
 - 2. No address provided
 - 3. No occupation provided
 - 4. No employer provided
 - b. *Keep It Alaska Independent Expenditure Group* may have accepted a Prohibited Contribution as defined 2 AAC 50.258(a) by accepting a contribution and not disclosing to the public the True Source of the funds.
- 2. Alaska Voter Coalition's 12/13/2024 24 Hour True Sources Report
 - a. Indicates *Keep It Alaska IE Group* acted as an illegal intermediary for \$3,000 income that reported the True Sources as:

- i. Trenitie Yundt on 10/21/2024
- ii. Anthony Pitvher on 10/21/2024
- iii. Robert Hall on 10/28/2024
- b. Indicates the purpose of the contribution was to benefit Robert Yundt, a candidate for State Senate, and Trenitie Yundt's husband.
 - i. At the time of the supposed contributions listed above, Alaska Voter Coalition's registration indicated that "more than 1/3 of total spending going to the following candidate(s).
 - 1. Robert Yundt
 - 2. Jubilee Underwood"
- c. *Keep It Alaska Independent Expenditure Group* acted as an intermediary by transferring a Prohibited Contribution to a separate group.
 - i. In doing so, *Keep It Alaska Independent Expenditure Group* may have violated 2 AAC 50.258(a)(7) by not meeting the statute's requirements for disclosing to the public the True Source of the funds.
- d. Keep It Alaska Independent Expenditure Group may have violated AS 15.13.070(c)(2) by contributing more than \$1,000 to another group.
- 3. Keep It Alaska Independent Expenditure has not disclosed on any report to the Commission an expenditure transferring \$3,000 to Alaska Voter Coalition on 12/12/2024.
 - a. Final reporting is due February 18, 2025.
 - b. Regardless of when the income and expenditures are reported, each violates Alaska campaign finance law in multiple ways.
- 4. <u>Keep It Alaska Federal SuperPAC</u> Reports of Receipts and Disbursements indicate the group never received or released any such contributions.
 - a. <u>Keep It Alaska Federal SuperPAC</u> quarterly reports indicate no income and only \$272.54 expenditure in the period 7/1/2024 to 9/30/2024.
 - i. Had the contributions listed above been made on the dates indicated, Keep It Alaska Federal SuperPAC quarterly reports would have included those contributions.
 - b. <u>Keep It Alaska Federal SuperPAC</u> pre-election reports indicate no income and no expenditures
 - i. Pre-Election Reports covered the 12 days leading up to the General Election on 11/5/2024.

- c. <u>Keep It Alaska Federal SuperPAC</u> post-election reports indicate no income and no expenditures
 - i. Post-Election Reports covered the 30 days following the General Election on 11/5/2024
 - ii. <u>Keep It Alaska Federal SuperPAC</u> included the period of 10/17/2024 to 11/25/2024 in this report.
 - iii. <u>Keep It Alaska Federal SuperPAC</u> reports \$300 income from Vince Pomeroy of Anchorage on 10/18/2024.
 - 1. No other income is reported for the period covered.
- 5. Keep It Alaska Independent Expenditure, Keep It Alaska Federal SuperPAC, Alaska Voter Coalition, and Red Dirt Campaigns represent an intricate web of relationships that, while may not violate specific laws, indicate planning and coordinating various campaign activities and illegal contributions, acceptance, use, and transferal of dark money in those campaign activities.
 - a. Alaska Voter Coalition reported \$3,000 debt to Red Dirt Campaigns.
 - b. Alaska Voter Coalition presumably used or intends to use the \$3,000 dark money contribution to pay its debt to Red Dirt Campaigns.
 - i. Red Dirt Campaigns is owned by **Joel Borgquist** of Eagle River, AK.
 - ii. Red Dirt Campaigns is owed \$3,000 by Alaska Voter Coalition.
 - iii. Red Dirt Campaigns received many payments from *Keep It Alaska Independent Expenditure Group* and made many in-kind donations to *Keep It Alaska Independent Expenditure Group*.
 - c. *Keep It Alaska Independent Expenditure Group* accepted and transferred prohibited dark money contributions as alleged above.
 - i. **Joel Borgquist** is the Chair of *Keep It Alaska Independent Expenditure Group.*
 - ii. **Thomas Detwyler** is the Treasurer of *Keep It Alaska Independent Expenditure Group.*
 - 1. **Chain Bridge Bank**, McLean Virginia is listed as *Keep It Alaska Independent Expenditure Group's* bank.
 - iii. **Thomas** Datwyler filed the 12/13/2024 *Keep It Alaska Independent Expenditure Group* 24 Hour True Sources Report.

- d. <u>Keep It Alaska Federal SuperPAC</u> is the unverified source of prohibited contributions of dark money through intermediary *Keep It Alaska Independent Expenditure Group*.
 - i. Thomas Datwyler the <u>Keep It Alaska Federal SuperPAC</u> Treasurer.
 - ii. Chain Bridge Bank, McLean Virginia is listed as the group's bank.

Alaska Campaign Finance Law Violations

- 1. Violation of AS 15.13.040(b): False Reporting of True Source
 - (a) Each group shall make a full report upon a form prescribed by the commission, listing
 - (1) the name and address of each officer and director;
 - (2) the aggregate amount of all contributions made to it; and, for all contributions in excess of \$100 in the aggregate a year, the name, address, principal occupation, and employer of the contributor, and the date and amount contributed by each contributor; for purposes of this paragraph, "contributor" means the true source of the funds, property, or services being contributed; and
 - (3) the date and amount of all contributions made by it and all expenditures made, incurred, or authorized by it.
 - (c) The report required under (b) of this section shall be filed in accordance with <u>AS</u> 15.13.110 and shall be certified as correct by the group's treasurer.
 - (d) Every person making an independent expenditure shall make a full report of expenditures made and contributions received, upon a form prescribed by the commission, unless exempt from reporting.
 - (e) Each person required to report under (d) of this section shall file a full report in accordance with $\underline{AS\ 15.13.110}(h)$ on a form prescribed by the commission. The report must contain
 - (1) the name, address, principal occupation, and employer of the individual filing the report;
 - (2) an itemized list of all expenditures made, incurred, or authorized by the person;
 - (3) the name of the candidate or the title of the ballot proposition or question supported or opposed by each expenditure and whether the expenditure is made to support or oppose the candidate or ballot proposition or question;
 - (4) the name and address of each officer and director, when applicable;

- (5) the aggregate amount of all contributions made to the person, if any, for the purpose of influencing the outcome of an election; for all contributions, the date of the contribution and amount contributed by each contributor; and, for a contributor
- (A) who is an individual, the name and address of the contributor and, for contributions in excess of \$50 in the aggregate during a calendar year, the name, address, principal occupation, and employer of the contributor; or
- (B) that is not an individual, the name and address of the contributor and the name and address of each officer and director of the contributor.

2. Use of Dark Money as defined in AS 15.13.400(5):

"dark money" means a contribution whose source or sources, whether from wages, investment income, inheritance, or revenue generated from selling goods or services, is not disclosed to the public; notwithstanding the foregoing, to the extent a membership organization receives dues or contributions of less than \$2,000 per person per year, the organization itself shall be considered the true source;

 "Dark money" was used since the contribution sources were not disclosed to the public.

3. Violation of AS 15.13.400(19): Misrepresentation of the True Source

"True source" means the person or legal entity whose contribution is funded from wages, investment income, inheritance, or revenue generated from selling goods or services; a person or legal entity who derived funds via contributions, donations, dues, or gifts is not the true source, but rather an intermediary for the true source; notwithstanding the foregoing, to the extent a membership organization receives dues or contributions of less than \$2,000 per person per year, the organization itself shall be considered the true source.

 "True source" means the person or entity that originally provided the funds, property, or services. It excludes intermediaries or conduits who merely transfer funds.

4. Violation of 2 AAC 50.258(a): Use of Intermediaries to Obscure Source

Dark Money Networks and Coordinated Electoral Deception in the 2024 Elections

(a) A contribution must be made in the name of the true source of the money or thing of value. A person may not make a contribution using the name of another, or use a third-party conduit to obscure the true source of any money or thing of value contributed to a campaign. A contribution in the name of another prohibited by this section includes any contribution:

1. Made at the Direction of Another Person:

Includes contributions made at the direction of another person, such as a parent organization, subsidiary, division, department, branch, or local unit of a business, labor union, or group.

2. Made by an Employee, Agent, or Other Person with Employer Assistance:

Contributions made by an employee, agent, or other person if an employer, principal, supervisor, or contractor lends, pays, or advances money or anything of value to the employee, agent, or other person to contribute in a name other than the true source.

3. Reimbursed Contributions:

Contributions made by an employee, agent, or other person if an employer, principal, supervisor, or contractor reimburses the employee, agent, or other person for the contribution in money or anything of value.

4. Exceeding Limitations via Multiple Groups or Nongroup Entities:

Contributions in a total amount exceeding the limitations in AS 15.13.070, if made to the same recipient by two or more groups or nongroup entities that:

- A. Share the majority of members of their boards of directors;
- B. Share two or more corporate or organizational officers, where:
- i. "Officer" has the meaning given in AS 15.13.040(r)(2); and
- ii. Includes a chief executive officer;
- C. Are owned or controlled by the same shareholders or members; or
- D. Are in a parent-subsidiary relationship.

5. Made Using a Gift for the Purpose of Contributing:

Contributions made by a person who receives a gift of money or anything of value from a parent, spouse, or domestic partner for the purpose of making a contribution.

6. Made from a Joint Bank Account Without Authorization:

Contributions made by check from a joint bank account in the name of any joint

account holder who does not either sign the check or authorize the contribution in writing at the time the contribution is made.

7. Made with Funds from Undisclosed Sources:

Contributions made with funds derived from contributions, donations, gifts, or dues whose source is not disclosed to the public at the time the contribution is made.

5. Violation of AS 15.13.070(c)(2): Exceeding limits on political contributions.

- (a)An individual or group may make contributions, subject only to the limitations of this chapter and <u>AS 24.45</u>, including the limitations on the maximum amounts set out in this section.
- (b) An individual may contribute not more than
- (1) \$500 per year to a nongroup entity for the purpose of influencing the nomination or election of a candidate, to a candidate, to an individual who conducts a write-in campaign as a candidate, or to a group that is not a political party;
 - (2) \$5,000 per year to a political party.
- (c) A group that is not a political party may contribute not more than \$1,000 per year
- (1) to a candidate, or to an individual who conducts a write-in campaign as a candidate;
 - (2) **to another group**, to a nongroup entity, or to a political party.

Harm to Alaskans

The misrepresentation of the true source of campaign contributions undermines the transparency critical to Alaska's campaign finance laws. Voters rely on accurate disclosures to understand who is funding political activities and to assess potential influences on candidates or issues. Hiding the true source of funds erodes public trust, obstructs informed decision-making, and enables illicit contributions and expenditures, potentially violating contribution limits or prohibitions on out-of-state or foreign funding.

Requested Remedies

- 1. Investigate the discrepancy in the reported true sources of the \$3,000 contribution.
- 2. Inspect the banking and credit card processing records of *Keep It Alaska Independent Expenditure Group*, and <u>Keep It Alaska Federal Super PAC</u> to identify the contribution(s) and expenditure(s) in question, and make those records available to the public should the Commission determine that the law was broken in the receipt or transfer of prohibited contributions.
- 3. Issue a formal determination of whether Alaska Voter Coalition, *Keep It Alaska Independent Expenditure Group*, or <u>Keep It Alaska Federal Super PAC</u> violated Alaska campaign finance laws by obscuring the origin of funds.
- 4. Issue a formal determination of whether the \$3,000 Prohibited Contribution is to be returned to the True Source(s) or surrendered to the State in accordance with 2 AAC 50.266(a).
- 5. Impose penalties as authorized under AS 15.13.390, including fines for false reporting and additional corrective actions.

- 3. With no way of guaranteeing future donations, how does one meet the 1/3 statute if they spend in any race but then expected donations do not materialize as planned for other races that were anticipated to be greater OR if they anticipate the earlier races being 1/3 or more but then receive greater donations than expected that push later races above the threshold? Some clarity would be much appreciated.
- 4. How does the 1/3 group naming statute align with the freedom of association in the US Constitution, whereas no group or individual can be compelled to associate with another group or individual? The US Government provides some excellent resources regarding this issue, including Congress (https://constitution.congress.gov/browse/essay/amdt1-8-1/ALDE_00013139/). The first paragraph, fourth to last paragraph, and second to last paragraph are very clear that we do not have to associate with any person or group against our will, particularly as it relates to political expression. The citations in each paragraph take you to specific US Supreme Court cases and US Law. Whereas IE Groups are specifically legally established by the First Amendment, it seems clear that Supreme Court rulings regarding freedom of association under the First Amendment must be respected. Can you give me some more clarity?

- 2. Additionally, it appears that you have amended your registration to indicate that more than 33 1/3 of your group's spending will be in support of Dave Bronson. Please note that under AS 15.13.050(b), you must include the candidate's name in your group's name. This statute is enclosed below my signature line.

- (a) Before making an expenditure in support of or in opposition to a candidate or before making an expenditure in support of or in opposition to a ballot proposition or question or to an initiative proposal application filed with the lieutenant governor under AS 15.45.020, each person other than an individual shall register, on forms provided by the commission, with the commission.
- (b) If a group intends to support only one candidate or to contribute to or expend on behalf of one candidate 33 1/3 percent or more of its funds, the name of the candidate shall be a part of the name of the group. If the group intends to oppose only one candidate or to contribute its funds in opposition to or make expenditures in opposition to a candidate, the group's name must clearly state that it opposes that candidate by using a word such as "opposes," "opposing," "in opposition to," or "against" in the group's name. Promptly upon receiving the registration, the commission shall notify the candidate of the group's organization and intent. A candidate may register more than one group to support the Revised May 2021 11 candidate; however, multiple groups controlled by a single candidate shall be treated as a single group for purposes of the contribution limit in AS 15.13.070 (b)(1).
- (c) If a group intends to make more than 50 percent of its contributions or expenditures in support of or in opposition to a single initiative on the ballot, the title or common name of the initiative must be a part of the name of the group. Mr. Borgquist,

Thank you for your patience with our response. The Commission has previously considered many questions about the activities of IE groups, such as Keep It Alaska. Shortly after the *Citizens United* decision, the Commission approved AO 12-09-CD, which, it seems, would provide guidance relevant to most of your questions.

1. Which statute prohibits candidates from being present at IE Group fundraisers/events?

There is not a specific statute, per se, that prohibits the candidate's attendance. However, as you are aware, independent expenditure groups are prohibited from making expenditures that are coordinated with a candidate. At the time of your question, your group's registration reflected an intent to focus a significant portion of its spending on the election of Dave Bronson so it is not clear how the expenses related to a fundraiser in which Mayor Bronson would attend as a guest speaker to raise funds on behalf of Keep It Alaska, would be made without coordinating with him.

2. The statute regarding the 1/3 contributions was unclear about the timeframe. Is that in a given election cycle or a shorter or longer time period?

This isn't specifically defined in the statute, but is based on a group's intended activities. See also AO 12-09-CD and 14-17-CD.

3. With no way of guaranteeing future donations, how does one meet the 1/3 statute if they spend in any race but then expected donations do not materialize as planned for other races that were anticipated to be greater OR if they anticipate the earlier races being 1/3 or more but then receive greater donations than expected that push later races above the threshold? Some clarity would be much appreciated.

Again, the statute is based on the group's intended activities and if you are able to provide more specific information about the group's planned activities, staff may be able to provide further guidance. See also AO 12-09-CD.

4. How does the 1/3 group naming statute align with the freedom of association in the US Constitution, whereas no group or individual can be compelled to associate with another group or individual? The US Government provides some excellent resources regarding this issue, including Congress (https://constitution.congress.gov/browse/essay/amdt1-8-1/ALDE_00013139/). The first paragraph, fourth to last paragraph, and second to last paragraph are very clear that we do not have to associate with any person or group against our will, particularly as it relates to political expression. The citations in each paragraph take you to specific US Supreme Court cases and US Law. Whereas IE Groups are specifically legally established by the First Amendment, it seems clear that Supreme Court rulings regarding freedom of association under the First Amendment must be respected. Can you give me some more clarity?

We understand your concerns, but constitutional questions such as this are likely better addressed to the lawmakers within the Alaska Legislature. As a state agency, it is our responsibility to enforce the laws as dictated by the legislature.

As to your questions about the mailer, staff has reviewed the content and notes the following:

- AS 15.13.090(a)(2)(C) requires identifying by Name, City, and State, Keep It Alaska's top 3 contributors.
- If Keep It Alaska is an outside-funded entity as defined under <u>AS 15.13.400(15)</u>, then <u>AS 15.13.090(g)</u> may apply ["a majority of contributions to Keep It Alaska came from outside the state of Alaska"]. While your example mailer states "all individual donors live in Alaska!" it is not clear whether this is intended for purposes of .090(g)

and without any understanding of Keep It Alaska's sources of funding, whether it might substantially satisfy the requirements of .090(g).

- AS 15.13.135 also requires the following statement be placed in the communication: "This NOTICE TO VOTERS is
 required by Alaska law. (I/we) certify that this (mailing/literature/advertisement) is not authorized, paid for, or
 approved by the candidate."
- Provided the photos used were not obtained through any coordination with the candidates, it would not appear
 to run afoul of our statutes or regulations.
