Subject:	Request for Exemption from Disclosing Spouse's Financial Information Elizabeth Reeves-Ramos, Fairbanks North Star Borough Assembly, Seat D

ISSUE

Elizabeth Reeves-Ramos, a Municipal Officer of the Fairbanks North Star Borough, is subject to Public Official Financial Disclosure (POFD) reporting. Ms. Reeves-Ramos is separated from her spouse and seeking a divorce.¹ She states that the divorce is highly contentious; she sought and was granted a long-term protective order against her spouse.² Ms. Reeves-Ramos seeks an exemption from reporting her estranged spouse's financial information on her 2025 Annual POFD Statement and any future reports until her divorce is finalized.³ Ms. Reeves-Ramos states that requesting such information from her estranged spouse would cause a concern for her personal safety and that she and her spouse have not commingled their funds since their separation in October 2023 and that "none of his income has been used for [her] benefit or support in the current filing year for 2024."⁴

Pursuant to this exemption request, staff reviewed the statutes regarding the disclosure of public officials' spouses' personal, business, and financial interests, standard exemptions from reporting, as well as past APOC interpretations or decisions and found no substantially similar requests or decisions. Accordingly, staff presents this recommendation for the Commission's consideration.⁵

LAW AND ANALYSIS

Under Alaska's POFD law, a municipal officer must file a statement identifying income sources and business interests.⁶ A filer's statement must be an accurate representation of their financial affairs and must disclose the same information for each member of their family, "to the extent that

it is ascertainable" by the filer after making a good faith effort to obtain the information.⁷ A filer is not exempt from disclosure requirements "except to the extent state courts determine that legally privileged professional relationships preclude complete compliance." ⁸

Through regulation, the Commission has recognized several exemptions to the requirement to report sources of income.⁹ A public official can seek an exemption from any POFD requirement by submitting a written request on or before the due date of any report to which it relates.¹⁰ As relevant here, a municipal officer may request an exemption from reporting any "information required under AS 39.50.030"—the statute that requires public officials to disclose the income sources and business interests of their family members—"that exposes the [municipal officer] to a personal security threat."¹¹

Additionally, a public official may request an exemption if they are "prohibited by law or courtordered settlement" or if they believe "reporting...any other information required under AS 39.50.030...would violate rights of the source under state or federal statutes or constitutions."¹²

Under ordinary circumstances, a filer must disclose the financial information of their spouse and if they do not have access to that family member's financial records, they must make a good faith effort to obtain the information by a written request to each family member.¹³ However, Ms. Reeves-Ramos indicates such communications would endanger her safety. Further, she provides a court order in which a judge found that her estranged spouse had committed an act of domestic violence and the judge barred the spouse from contacting Ms. Reeves-Ramos directly or going to her home and workplace. So even if Ms. Reeves-Ramos tried to obtain information about her spouse's income and business interests, if her spouse directly replied to such a request he would be in violation of a court-issued protective order.

RECOMMENDATION

Staff recommends that the Commission grant Ms. Reeves-Ramos's request for an exemption from disclosing financial information for her estranged spouse. (Because a similar matter has not come before the Commission, staff is unable to grant Ms. Reeves-Ramos's request for an exemption and instead presents its recommendation to the Commission.) In reaching this recommendation, staff notes that Ms. Reeves-Ramos has presented evidence—both in the form of her certified exemption request and in the court-issued protective order—that she will be exposed to a personal security threat if she attempts to obtain and disclose her estranged spouse's income sources and business interests. Staff also considered that one purpose of AS 39.50 is to assure that public officials are free from the influence of undisclosed private or business interests and to develop accountability by permitting public access to information necessary to judge the credentials and performance of public office holders. Because Ms. Reeves-Ramos does not commingle her funds with her

spouse's and her spouse's funds were not used for her support or benefit, her estranged spouse's income sources and business interests have diminished (if any) relevance to Ms. Reeves-Ramos's influences and credentials.

In sum, staff recognizes the conflict between the requirement to disclose her spouse's financial affairs and the court-ordered restraining order against her spouse, in addition to her concern for her personal health and safety and therefore recommends that the Commission grant Ms. Reeves-Ramos's request for an exemption from disclosing financial information for her estranged spouse.
