### **Tuesday, November 3, 2026 General Election**

<b>24 Hour Reports*</b>	October 25 – November 2	<b>Daily As Needed*</b>
<b>Year End Report</b>	October 25 – February 1, 2027	<b>Tuesday, February 16, 2027</b>

\*During the 9 days before either election, contributions in excess of \$250, from a single source, must be reported by date, amount, and contributor within 24 hours of receipt. This includes all monetary and non-monetary contributions as well as contributions that aggregate over \$250 in the aggregate from a single contributor during the nine-day period. You may need to report each day during that period, or not at all.

**Independent Expenditure/Ballot Proposition Groups: please note your group is required to file Independent Expenditure Reports (15-6) in addition to the reports listed above.** Independent Expenditure Reports must be filed no later than 10 days after the expenditure has been made, unless the expenditure exceeds \$250 and is made within 9 days of the election. In that case, the report must be filed within 24 hours.

**Independent Expenditure Groups that make IE(s) in Candidate Elections** (and groups that made or are making independent expenditures in candidate elections in the previous and current election cycle) must file an additional 24-hour report when receiving a contribution in excess of \$2,000 in the aggregate from a single contributor at any time during the election cycle.

Every individual, person, or group contributing a total of \$500 or more to a ballot group or initiative proposal application group must file a **Statement of Contribution Form (15-5)** within 30 days of making the contribution.

Every individual, person, or group that contributes **a total of \$2,000 or more to an IE group, group, or entity** that has made or is making independent expenditures in **candidate elections** in the previous or current election cycle must file a Statement of Contribution Form (15-5) **within 24 hours of making the contribution**.
