Reports

MAXIMUM CIVIL PENALTY: \$410 – filed 41 days late

2007 First Year Filer – No other late reports as they not registered until November 2007. Filer had not employed a lobbyist in Alaska until the 4th quarter of 2007. Filer erroneously considered the employer to be the home office in New Jersey and was not aware of the need to file a report. Filer does not dispute the fact that some type of mass distribution email went out but has no recollection of receiving it. APOC did not send a US mail notification of the overdue report until one and ½ months after the filing deadline, incurring over \$400 in fines by that time. Filer staff took online training and sought assistance and clarification from APOC via phone and email several times, and responded to the overdue report notification on the day it was received.

Staff Analysis of Facts for Commission Review and Staff Recommendation:

- o Affiant is a first time filer.
- o First notice of delinquency letter was sent 03/04/2008. The report was signed on 03/10/2008 and faxed on 03/12/2008.
- O An APOC courtesy e-mail reminder was sent to lobbyists and employers on January 4th reminding them that the 4th Quarter report was due on January 31st. Eileen Sullivan of Hoffman LaRoche was on the distribution list.

Staff Recommendation

Submitted the late report within eight days of the date of the notice. There was a good faith effort made in contacting APOC. There were valid filer reasoning regarding status as employer of lobbyist.

Commissioner Dean made a motion to assess a civil penalty of \$205 or 50% of the maximum civil penalty of \$410 for late filing.

Commissioner Ballenger seconded the motion.

The Commission determined that the Filer should have the penalty reduced by 50% to \$205 since the Filer was a first time filer.

o The maximum penalty should be waived due to staff error by failing to mail the forms to a correct address.
