#### **Other Relevant Dates for the 2014 State Primary Election:**

**Friday, July 15, 2016** (33 days prior to the date of the Primary Election)

The last day a candidate may give or loan their campaign more than \$5000.

**Friday, September 30, 2016,** (45 days after the date of the Primary Election)

The last day a candidate may accept contributions.

**Wednesday, February 1, 2017**

The date by which candidates must distribute the amount held in their campaign account.

### **Tuesday, November 8, 2016 General Election**

<b>Final Report</b>	October 30 – February 1, 2017	<b>Wednesday, February 15, 2017</b>

#### **Other Relevant Dates for the 2016 State General Election:**

**Friday, October 7, 2016** (33 days prior to the date of the General Election)

The last day a candidate may give or loan their campaign more than \$5000.

**Friday, December 23, 2016** (45 days after the date of the General Election)

The last day a candidate may accept contributions.

**Wednesday, February 1, 2017**

The date by which candidates must distribute the amount held in their campaign account.

\* Due date is on a holiday – will be considered timely, if completed the next business day

\*\*During the 9 days before an election, you must report the contributor name and amount of all monetary and non-monetary contributions over \$250 to APOC within 24 hours of the time you receive each contribution.

You may need to report each day during that period, or not at all.
