This is the current status of the FY26 budget.

Personnel: FY26 has nine budgeted full-time staff positions. Currently six are filled with the LOA2 having been vacant since December of 2023. We recently filled the LOA3 position and have received waivers to recruit for both paralegal positions. With the anticipated level of campaign activities expected for the 2026 state election cycle, I have decided to continue overseeing the POFD area of law and to dedicate both paralegal positions to the campaign disclosure team.

Given the length of time the LOA2 position has been vacant, it is entirely possible that it will be cut during this budget cycle. Although DOA did not recommend it be deleted in its FY27 budget proposal, it will likely be scrutinized when the budget makes its way through the legislature. When a position is deleted, the associated funding for the position will also be cut. If that happens we would then need to rely on holding other positions vacant. This is a problem, but given the state of declining state revenue, I do not foresee it improving anytime in the near future.

FY26 will see the deadline for candidates to file for the 2026 state election. 2026 will be a gubernatorial election and will likely see another ballot measure aimed at repealing the open primaries and ranked-choice voting. It will be a busy and contentious election cycle, and it is highly unlikely that we will be able to catch up with the backlog of complaints, let alone keep up with those that will come with the new election cycle.

Travel: Travel should still cover all costs for Commissioner travel for FY26 in-person meetings. I was able to get approval for out-of-state travel which enabled Kim Stone, our campaign disclosure coordinator, to attend the annual COGEL conference held in Atlanta in December.

Contractual: Includes general contractual fees, overhead costs and chargebacks for centralized services provided by the Department of Administration. It is an area where we have little control. Right now there is a significant projected shortfall (~\$110,000) in this line which will require funds be moved from the personnel line to cover it.
